SPAS

- Produces sparkling clean and clear water with one drop for every 250 gallons of water.
- Dissolves oils and organic residues.
- Reduces chemical usage and vapors.

Directions: Add one drop (1ml.) for every 250 gallons (1,000 liters) once a week, or before use of spa.

Directions: For the first week, add 5 capfuls (2 1/2 oz) for every 10,000 gallons (100 ml per 100 m3) of water into the pool skimmer/filter box. Thereafter, each week, add 2 capfuls (1/2 oz) for every 10,000 gallons (40 ml per 100 m3) of water into the pool skimmer/filter box. If the pool is very heavily used, add twice a week.

Oxidative agents are also irritating to skin and eyes, as well as producing volatile compounds which can impair breathing in many people.

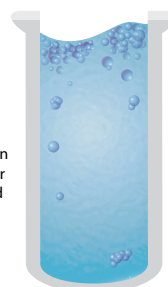
